The "Build a School in Burma" (BSB) program made grants and oversaw grant expenditures in Burma, also known as Myanmar, that resulted in construction of school buildings or renovations for existing buildings in 7 communities, providing classroom space for over 500 students. Some grants were made to allow existing schools to add grade levels, some were to relieve overcrowding, and some were to replace temporary bamboo and thatch buildings with long-lasting buildings. All were to provide safe, secure learning environments for students in poor, underserved communities.

4b (Code:) (Expenses \$ 86,600 including grants of \$ 86,600) (Revenue \$ 84,508)

"APC School" program made grants to support ongoing operations of Apu Palamguwan Cultural Education Center (APC) which provides an integrated and holistic education for the indigenous children and youth along the Pantaron Range of Mindanao, Philippines. The APC school works to promote and deepen cultural understanding while providing approximately 400 indigenous children with the knowledge and skills they need to confidently relate with mainstream Philippine society and advance in the formal education ladder.

4c (Code:) (Expenses \$ 145,733 including grants of \$ 145,733) (Revenue \$ 92,331)

The program "Build a School in India"(BSI) makes grants that support educational activities in India. The largest grants have been to support the Mata Balak Utkarsha Pratishathan (MBUP), Utkarsha Vidyalay school that provides educational opportunities for underserved children in Sangola, Solapur District, Maharashtra, India. Grants this year also included programs to sustain education during the COVID-19 pandemic, including support for digital on-line learning. Another grant helped finance construction of a student hostel, and another a vehicle for a women's micro-finance NGO.

Schedule F, Part I, Line 2 - PBF provides a Proposal form to prospective grantees, stating PBF's mission, grant criteria, and grantee requirements, and how use of funds will be monitored. After a grant proposal has been submitted to PBF the PBF Executive Committee (EC) along with the Country Director (CD) evaluate the proposal. Typically the CD and one or more of the EC will visit the site of the proposed grant project, meet with the grantee organization leaders, and gather information and make inquiries, to decide whether to make the grant. Documents include (1) Grant Proposal, (2) Budget, (3) Photos of proposed building site and environs. The EC, along with the CD, evaluate proposals primarily for the expected impact towards achieving PBF's mission. If a decision is made to make a grant, a Grant Agreement is drafted and signed. The documents are recorded in a "Slack" database in a channel for each grant. After a grant is made the PBF CD monitors to ensure funds are properly used in accord with terms of the grant, primarily through site visits and phone contacts, and the CD documents grant status in monthly reports and photo logs. These are saved in the Slack database, for access by members of the PBF EC. For grants made by the APC School and for Build a School in India, monitoring of grants is performed by review of periodic and annual reports from the grantee, and ongoing communication between the the PBF program manager and the grantee.

These schools teach the standard curriculum, and also teach Buddhist religion. Two small buildings had been made by the villagers own efforts, but were in very bad condition before BSB offered to help. Construction began in early 2020. When the truck delivering construction materials got stuck a mile from the construction site, villagers carried the building materials by whatever means they could - by motorbike, hand-carry, and buffalo-pulled sledge. Construction was successfully completed in November 2020, and the community is enthused to have a new school building. The new building also provides a place for immunizations, parents meetings, and night lighting for teachers.

Nevertheless, 60 children from the age of 3 to 5 years attend. Several years ago construction on a new building was started but never completed. The school committee asked for help to complete the unfinished building. BSB agreed to help complete the building to produce a proper and safe learning environment. Construction was completed in December 2020, largely the result of the efforts of the enthusiastic and highly engaged people of Tet Tet Gu village, including parents, the school committee, and community leaders.

Grant A new building for Kon Lan Primary School. Kon Lan is a small village a little over an hour's drive from Hopone, Southern Shan Statem, Myanmar. The village is far from any other villages, so the village school is the only place for the children to be educated. It is a government primary (kindergarten - 4) school with 22 students and three teachers. The temporary school built by the villagers is just made of flimsy thatch. Water comes into the classroom during monsoon rains. Working with Naung Taung Monastic School in Hopone, BSB helped build a new brick school building for Kon Lan. The new school includes a rooftop solar electricity system to provide night lighting. New furniture provides the students quality workspace for their lessons. Construction began in early 2020, and was completed in September 2020.

Small cash grants, food assistance, and other aid was given through local Myanmar NGO's. In total \$15,361 in aid was distributed. This program may or may not be continued, depending on conditions in Myanmar, including operations of the local Myanmar NGO's, feasibility of fund transfers, donor support, and the current need for aid.

Form 990, Part III, Line 3 - The Build a School in Burma (BSB) program has halted school construction projects, in response to recent events in Myanmar. Events and conditions include: A military coup in February, the Civil Disobedience Movement (CDM), the collapse of banking and financial systems, severe limitations on travel, and general security issues have made construction projects impossible. BSB is continuing to evaluate the situation, to determine whether and when BSB can continue its primary objective, to build much-needed schools in Myanmar.
