The "Build a School in Burma" (BSB) program made grants and oversaw grant expenditures in Burma, also known as Myanmar, that resulted in construction of school buildings or renovations for existing buildings in 12 communities, providing classroom space for over 800 students. Some grants were made to allow existing schools to add grade levels, some were to relieve overcrowding, some were for new schools, and some were to replace temporary bamboo and thatch buildings with long-lasting buildings. All were to provide safe, secure learning environments for students in poor, underserved communities.

4b (Code: _____) (Expenses \$ 88,850 including grants of \$ 88,850) (Revenue \$ 90,205)

"APC School" program made grants to support ongoing operations and expansion of the Apu Palamguwan Cultural Education Center (APC) which provides an integrated and holistic education for the indigenous children and youth along the Pantaron Range of Mindanao, Philippines. The APC school works to promote and deepen cultural understanding while providing approximately 400 indigenous children with the knowledge and skills they need to confidently relate with mainstream Philippine society and advance in the formal education ladder. One special grant provided funding for construction of a new building.

4c (Code: _____) (Expenses \$ 4,004 including grants of \$ 4,004) (Revenue \$ 138,052)

The program "Build a School in India"(BSI) makes grants that support educational activities in India. The largest grants have been to support the Mata Balak Utkarsha Pratishathan (MBUP), Utkarsha Vidyalay school that provides educational opportunities for underserved children in Sangola, Solapur District, Maharashtra, India. This year several start-up grants were made by BSI to initiate vocational training and micro-finance instructional and support programs that are expected to expand in the coming years.

Schedule F, Part I, Line 2 - PBF provides a Proposal form to prospective grantees, stating PBF's mission, grant criteria, and grantee requirements, and how use of the grant funds will be monitored. After a grant proposal has been submitted to PBF, the PBF Executive Committee (EC), along with the Country Director (CD), evaluate the proposal. Typically the CD and one or more of the EC members will visit the site of the proposed grant project, meet with the grantee organization leaders, gather information and make inquiries, to decide whether to make the grant. Documents include (1) Grant Proposal, (2) Budget, (3) Photos of the proposed building site and local environment. The EC, along with the CD, evaluate the proposals primarily for expected impact towards achieving PBF's mission. If a decision is made to make a grant, a Grant Agreement is drafted and signed. All these documents are recorded in a "Slack" database, channel specific to the grant. After the grant is made, the PBF CD monitors progress towards achieving the purpose of the grant, primarily by making periodic visits to the site, and documents in monthly reports and photo logs. to ensure funds are properly used in accord with the terms of the grant. The monthly reports are saved in the "Slack" system, which is accessed by members of the PBF EC. Throughout the year, PBF board members review results of each grant, including compliance with terms of each grant. For grants that are for programs or activities, not for construction, a different process is used. For grants such as to the "APC School" program, and the "Build a School in India" program, monitoring of grants is performed by review of annual and periodic reports from the grantee, and ongoing communication with the program manager and the grantee. The "cash" basis of accounting was used for all grants. The primary beneficiaries of PBF grants are the approximately 1,000 students in the schools benefited by grants of PBF this year. Other persons who benefited are the teachers, and families of the students.

A local non profit that is helping the villagers, the Karen Women's Empowerment Group, ("KWEG") asked BSB to help - to provide a safe, good quality learning environment for the students, and classroom space for middle-school. Construction of a new 30" by 90" began in early 2020, and is expected to be completed by fall 2020.
